Show Fees

- SUROK members' cats: €42 per cat for one day or €78 per cat for both days
- FIFe members: €44 per cat for one day or €82 per cat for both days
- Non-FIFe exhibitors: €50 per cat
- Veteran class in addition to regular judging: €25; if entered only in the veteran class, the standard show fee applies. Control class: €25
- Breeder and progeny classes are free of charge when the cat is entered in another class.

Show Catalogue: €6 when ordered and paid for via Omakissa. A complimentary electronic catalogue will be published on the morning of 8 August 2026.

Entries are preferably submitted via the **Omakissa system**. Show fees are payable immediately upon entry. If entry via Omakissa is not possible, written entries will also be accepted. Please complete a separate entry form for each day. Proof of payment must be enclosed with paper entries. Entries will be accepted in the order received.

The first 500 entries for each day will be confirmed.

Stewards can send their applications until 15 July 2026 by email to assistentit@surok.fi. Assistants will receive lunch and remuneration (€40 or one show fee code per day).

Breed Club Tables and Commercial Stands may be reserved until 15 July 2026. Breed club tables €20 per day include one table measuring 180 x 80 cm. Commercial stand space is available by separate agreement. Reservations: kauppiat@surok.fi.

Veterinary Inspection:

Saturday 7:30-9:00, Sunday 7:30-8:30

The latest acceptable vaccination date is 15 days before the show, **i.e. 24 July 2026**.

Vaccination certificates will be checked for all cats. Veterinary inspections will be carried out on a spot-check basis. According to veterinary requirements, each cat must have valid vaccinations against feline panleukopenia and cat flu (herpesvirus and calicivirus). Booster vaccinations and validity periods must comply with the vaccine manufacturer's instructions. **Please note that for the Tricat combination vaccine, the panleukopenia component is valid for three years, whereas the cat flu component is valid for one year only and must therefore be renewed annually.** A cat's primary cat flu vaccination is valid only after the second vaccination (booster).

Judging Schedule: Saturday from 9:30, Sunday from 9:00. All breeds will be judged on both days.

The show closes at 17:00. Permission for non-nominated cats to leave will be announced during the day, no earlier than the close of public visiting hours. The exhibition is open to the public from 10:00 to 15:00.

Show Cages: Cage size 65 x 65 x 56 cm. No double cages. Cages will be arranged within the judging rings by category and will not be pre-numbered. The show follows the European style, with exhibitors inside the ring and visitors outside. Cages may not be fully covered, so that the cats remain visible to the public. Certificates and title rosettes are provided free of charge and may also be exchanged for stamps. Stamp cards are in use.

The show will be conducted in accordance with the rules of FIFe and the Suomen Kissaliitto. Exhibitors may present their own cats to the judge.
